EU-ILO Technical Assistance Facility on the Youth Guarantee (YG) Peer Learning Event on Preparedness for piloting the YG



The objective of this peer-learning event is to support the five Western Balkan economies that will soon begin to implement the Youth Guarantee (YG) for the first time in assessing their preparedness to move to Stage 3 (Pilot phase – see figure below). As reiterated throughout the process leading to the formulation of the YGIPs, the first set of milestone relates to the reform of the organizational and functional structure of the public employment service (PES). These reforms are a pre-condition to enable the functioning of the YG service delivery system (registration, preparation services, quality offers). These are accompanied by the process of setting up of the YG monitoring system. If the WB economies cannot pursue multiple streams of work simultaneously but have set ambitious dates for the start of the pilot phase, priority shall be given to the realization of the PES reform over other planned reforms and actions envisaged in the other YG phases (mapping and early intervention, and outreach).

Flagship 10 of the EIP for the Western Balkans



The event will take place over one full day (3 October), followed by a final session, on 4 October, for all participants, and an additional session reserved to the YG coordinators.

Prior to the event, participants will receive background information on each session. The content of the background papers will be presented by EU-ILO TAF experts at the beginning of each peer learning session to launch the discussion. After the initial presentation, participating delegations will be asked to animate the peer-review and to respond to the guiding questions. Then, other delegations will be invited to ask additional questions of clarification and continue the peer-review process.

Financed through ILO's RBTC/SSTC (South-South and Triangular Cooperation) resources, this peer-learning event takes a very pragmatic approach, based on dialogue and sharing of experiences. With no ambition of summarizing or replacing all the capacity development interventions that have taken place since the launch of Flagship 10 under the Economic and Investment Plan (EIP), this event will work like a pre-flight checklist in the aviation sector: It will review a list of tasks that should be performed by Youth Guarantee Coordinators and their 'crews' prior to piloting the youth guarantee. Informed by the experience of the EU-ILO TAF's technical experts working in the region and the lessons learnt from the EU Member States, the purpose is to improve the framework conditions for the implementation of the pilots by ensuring that no important tasks are forgotten.
